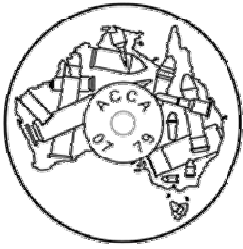

In all states of Australia, it is a requirement by law that a Licence, Permit or Authority to collect ammunition, be obtained to legally possess collectable cartridges.

ACCA Inc. is recognised under current legislation in all states of Australia. The Association makes representations to politicians and relevant government bodies to protect the interests of cartridge collectors and enhance their standing within the wider community.

In some states, ACCA Inc. membership satisfies the requirements for a 'Genuine Reason' to obtain a Permit/Licence/Authority from the statutory state body. Prospective members who require a 'Genuine Reason' as described above, will be granted 'provisional membership' while the relevant Permit, Licence or Authority to collect cartridges is being obtained.

Until the Membership Secretary receives a copy of any member's current appropriate 'Licence, Permit or Authority' such membership will be deemed 'provisional' and that member will not be able to participate in ACCA Inc. cartridge related activities.

ACCA Inc. also offers membership to those who do not wish to possess collectable cartridges but these members will not be permitted to buy, sell, swap or possess collectable ammunition.

ACCA Inc. seeks to foster good citizenship and will not knowingly accept for membership any person having a criminal conviction which would disqualify that person from legally collecting cartridges in the state, territory or country of residence.

The Association fosters and promotes the preservation of, research into, and recording of historically significant material in the form of collectable cartridges and related materials.

The Association seeks to assist members by providing opportunities to acquire new specimens and technical knowledge, and to increase the number of active collectors throughout Australia and overseas.

New applications will follow the guidelines stated above.

Membership renewal forms must be completed by January 1st each year by all members. A copy of the member's current appropriate 'Licence, Permit or Authority' must accompany the renewal form.

Fees are due and payable on January 1st each year.
